

# Terms and Conditions of the "Best Review" Contest on Watchard.com

## 1. The Organiser and duration of the Contest

The Contest is organised by Watchard.com owned by 57 Concepts Sp. z o.o. Sp.k. (hereinafter referred to as the 'Organiser') with its registered office at Al. Witosza 31/115, 00-710 Warsaw.

Duration of the Contest: from 1st March 2023 until further notice.

## 2. Rules of the Contest

The "Best Review" Contest is open to our customers and anyone who has liked our Facebook page.

The subject of the Contest is the most interesting review of any watch available at Watchard.com.

The Contest runs from 1st March 2023 and shall continue until it is cancelled by the Organiser. At the end of each month, the three most interesting reviews will be selected and rewarded with vouchers of PLN 300, PLN 200 and PLN 100. There are no specific limits to the number of characters, but longer reviews will have a greater chance of winning.

Each Participant can send us as many reviews as they wish, provided that each review is posted under the corresponding watch model, at [www.watchard.com](http://www.watchard.com).

To participate in the Contest, a Participant must declare that they are the author of the review and hold exclusive copyright to the submitted text. The review cannot be a copy of another review or contain any fragments from other reviews.

By participating in the Contest and submitting an entry with a declaration, each Participant transfers all proprietary copyrights for their review to the Organiser of the Contest free of charge for all fields of exploitation without limitations in terms of territory and time. A Participant assumes full responsibility in the event of any third-party claims to their submitted review.

The reviews submitted to the Contest shall not violate the law, infringe the personal rights of third parties and generally accepted social norms. In addition, they shall not contain erotic, racist, fascist, or any other offensive or vulgar content. Reviews that incite illegal acts or offend the feelings of others, particularly the religious ones, are not acceptable.

## 3. Participants

This Contest is open only to natural persons who have reached the legal age of majority in their province or territory of residence at the time of entry. Persons participating in the contest are called Participants.

## 4. Contest participation

To participate in the Contest, leave us a review on any watch of your choice under the corresponding model at [www.watchard.com](http://www.watchard.com). Tick the checkbox that says 'I want to take part in the Contest', enter your email address, accept the Terms and Conditions of the Contest and submit your review.

Participants who enter the Contest and send their reviews after the Contest has ended will not be considered. Participation in the Contest is free of charge.

All Participants, by entering the Contest, and especially by fulfilling the conditions referred to in point 4., agree for their personal data to be used by the Organiser for the purposes of the Contest under the terms of the Personal Data Protection Act of 29 August 1997 (unified text: Journal of Laws of 2002, No. 101, item 926). The Administrator of the personal data collected for this Contest within the meaning of the Act of 29 August 1997 on the Protection of Personal Data (unified text: Journal of Laws of 2002, No. 101, item 926) is the Organiser. The Participant gives consent to the publication of their name, surname, place of residence and age in any Contest-related materials.

By submitting your entry, you agree to grant the Organiser permission to use your piece of work without any charge in all fields of exploitation, including audio, video, print, and the Internet without limitations in terms of territory and time. Additionally, you authorise the Organiser to make any developments or modifications of the works, and use the results of the developments in the aforementioned forms, in particular to publish the submitted reviews on [www.watchard.com](http://www.watchard.com) and Facebook fanpage of Watchard.com.

Upon entering the Contest, a Participant agrees that from the date of submitting their review to the Organiser, they grant the Organiser a perpetual and free of charge licence to publish and distribute the submitted text.

## 5. Selection of winners

All entries submitted to the Organiser that comply with the Terms and Conditions of this Contest will be eligible.

The winner will be selected at the end of each month by the Jury consisting of Watchard.com employees.

The basic criteria for the evaluation of the submitted reviews are: substantive correctness, compliance with the description of the watch, linguistic correctness, creativity, aesthetics and quality of the photo (if the photo is submitted).

In the Contest, three prizes can be won: a PLN 300 voucher, a PLN 200 voucher and a PLN 100 voucher. All vouchers can be redeemed when purchasing a watch priced above PLN 500 on Watchard.com.

There is no appeal procedure against the decisions of the Jury.

The list of winning entries shall be announced on the Facebook fanpage of Watchard.com within 10 days of the end of voting.

## 6. Processing of personal data

The Administrator of the personal data collected for the Contest is 57 Concepts Sp. z o.o. Sp.k. (the owner of Watchard.com) with its registered office at Al. Witosza 31/115 (room 115), 00-710 Warsaw.

By filling in the form, the Participants have the right to consent to the processing of their personal data (full name, email address) by 57

Concepts Sp. z o.o sp. k. with its registered office at Al. Witosa 31/115 (room 115), 00-710 Warsaw for the purposes related to the organisation of the Contest as well as promotional and marketing activities in accordance with the Act of 29 August 1997 on the Protection of Personal Data (unified text: Journal of Laws of 2002, No. 101, item 926, as amended).

Pursuant to the Act of 29 October 1997 on the Protection of Personal Data (Journal of Laws of 29 October 1997, No. 133, item 883 with later amendments), the Administrator of the database hereby ensures that all Participants can access, correct or delete their data. Participants have the right to agree to receive commercial information electronically on their terminal equipment in the form of email messages within the meaning of Article 10 (1) of the Act of 18 July 2002 (Journal of Laws, No. 144, item 1204) on Providing Services by Electronic Means.

The processing and use of personal data shall be conducted in accordance with the Act of 29 August 1997 on the Protection of Personal Data. Pursuant to Article 24(1)(3) and (4) of the aforementioned Act, the provision of data is voluntary, and each Participant has the right to access and correct their data.

The Administrator collects data on Participants' involvement in the Contest, in particular the receipt of messages related to the Contest and the statistics of opening and rejecting these messages, as well as the number of Participants who decided to take part in the Contest.

The purpose of processing the Participant's personal data is to process the Contest entry and send the prize to the winners of the Contest.

The Participants' data are exclusively processed by certain employees of the 57 Concepts Company to the extent approved by the Administrator.

The data Administrator uses a dedicated software to process the data. The Administrator undertakes to comply with the following principles:

- The Administrator will only collect and process personal data necessary for the administration of the Contest.
- The Administrator ensures the security and confidentiality of information provided by registered Participants in accordance with applicable law. Compliance with these standards shall be continuously reviewed and revised as necessary.
- The Administrator shall make every effort to protect the privacy of its users and store Participants' personal data in accordance with applicable law. The Administrator undertakes not to sell Participants' personal data and to protect the data collected with the greatest possible care.
- The Administrator has appointed a Data Protection Officer to supervise the accuracy of personal data processing and verify its compliance with the law. The officer may be contacted by:

## 7. Conditions of withdrawal

The message should contain the data provided in the application form, in particular email address, name and surname as well as the name of the Contest. Upon withdrawal from the Contest, the Participant's entry will be removed from the submitted entries.

## 8. Final provisions

The Organiser reserves the right to amend these Terms and Conditions without stating a reason, provided that this does not deteriorate the conditions of participation in the Contest.

The Organiser reserves the right to unilaterally suspend or terminate the Contest at any time without selecting the winner(s) and without having to justify this decision.

The Organiser may exclude the Participant(s) from the Contest in the event of any breach of these Terms and Conditions.

If there are any doubts about whether a Participant has violated these Terms and Conditions, specifically in regards to the copyright of the submitted entry, the Organiser reserves the right to:

- a) withhold the prize until all doubts are dispelled,
- b) exclude the Participant from the Contest,
- c) refuse to grant the prize,
- d) demand the return of prizes and compensation for their damages in the case of previously awarded prizes.

Any disputes that may arise between the Organiser and a Participant shall be settled by a common court competent for the seat of the Organiser.

In matters not regulated by these Terms and Conditions, the final decision shall be taken by the Organiser.

In all matters not regulated by these Terms and Conditions, the provisions of the applicable Polish law shall apply.
